## **Description of the Internship**

The history of migrations to Italy began more than 40 years ago and in the last ten years over 50.000 migrants have landed in Sicily. The concept of health as a fundamental individual right is enshrined in Article 32 of the Italian constitution. Consequently, any foreigner present in Italy, regardless of his or her status, is entitled to access public health services. Nevertheless, health services provided to migrants mostly adopt an assimilation model rather than a multicultural one. As future doctors, we should acquire theoretical knowledge and practical skills in order to face this phenomenon guaranteeing migrants' rights to access health care. This is the reason why we consider crucial for medical students to do an internship in a specialized department to be able to perform the right work-up of the patient.

**Problem Statement:** Please describe the main issue(s) addressed during the internship:

Migrants are not a homogeneous group, in Sicily we have different subgroups having different social, economic and cultural circumstances that account for their varying vulnerabilities throughout the migration process. That means that the process of migration itself is a social determinant of health and the student will have to face different experiences during transit and travel, different legal status of the individual, different working and living conditions to which migrants are subject. Social and cultural barriers to integration, acculturation stress, exclusion and discrimination, changes in lifestyle and loss of family and friendship networks are additional factors impacting the health of migrants that the student will have to consider and analyze carefully.

**What is the main goal(s) of the Internship?**

The main goals of the internship are:

- gaining awareness of the medical, cultural, linguistic and metalinguistic barriers in the access to health care allowed to map the gaps between migrants' needs and services provided;
- training medical students on managing diversity;
- learning the current interventions and best practices to promote the health of migrants in Sicily

What are the objectives of the Internship?

The objectives of the Internship are:

-learning fundamentals in order to provide multicultural care, such as knowing others as cultural beings, developing nonverbal and verbal communication skills that facilitate mutual understanding, applying patient-centered multicultural communication models in clinical encounter and developing multicultural negotiation skills;

-Promoting health literacy among migrants

What is the expected outcome(s) of the Internship?

The student will have to produce a report about a case study or a specific topic at the end of the exchange.

The impact will be assessed in the student's report at the end of his internship.
